With previous conferences held in Spain, Canada, Denmark and the United Kingdom, the upcoming conference is the first to be held in the Southern Hemisphere. ***Innovations in Regulation*** is hosted by the ***Nurses Board of Victoria*** and the ***Nursing Board of Tasmania*** and convened by the ***Australian Nursing Council Inc.***
